#### 1. ELIGIBILITY

- Unpaid Position (Honorariums & Hobby Payments Accepted)
- o Active in a volunteer only role within the Club or Discipline or MNT or MA
- Can be involved in any capacity of the Club or Discipline or MNT or MA

Nominees do not have to be involved at all levels.

# NOMINATE HERE

#### CRITERIA:

#### 1. ELIGIBILITY

- Unpaid Position (Honorariums & Hobby Payments Accepted)
- o Active in a volunteer only role within the Club or Discipline or MNT or MA
- o Can be involved in any capacity of the Club or Discipline or MNT or MA
- o Individuals can only receive one Community Club Award

Nominees do not have to be involved at all levels.

#### 2. SERVICE

- Provide summary of the nominee's roles/service to the sport.

Each club is eligible for a maximum of one recipient per year.

Each independent advisor group delegate and MNT CEO may also nominate a maximum of one recipient per year.



# DISTINGUISHED SERVICES AWARD

A Club/Discipline can only nominate one person for this prestige award. A Distinguished Service Award can only be received once, and no more than 4 will be awarded annually.

- Must have completed 20 years continuous service at either Club/Discipline/State Level.
- Not a MNT or MA Life Member

• Be a current affiliated club of MNT

#### 2. ADMINISTRATION

- Proficient use of competition management system (RiderNet)
- o Active use of website and/or social media
- Business growth and/or facility development projects
- Marketing/partnership opportunities
- o All management complete WWCC and submitted into database
- o Committee meetings held and documented, available to membership
- Effective communication and positive relationship with MNT
- Submits feedback into MNT reviews and/or post event surveys as applicable

- Promoted, conducted and participated in Official Courses/programs

- Be a current financial member of MNT
- o Did not hold the role of President of their Club in the period

# NOMINATE HERE

#### CRITERIA:

#### 1. ELIGIBILITY

- o The host must be an affiliated Motorcycling NT Club
- o The event must have been held during the eligibility period
- The event must have been hosted in the Northern Territory
- The event must have been permitted by Motorcycling NT and have been permitted through the RiderNet system.

#### 2. ENGAGEMENT

- Demonstrated how the event was key in successfully driving positive interaction with the members and community
- Growth in localised participation
- Positively promoted Motorcycling Sport
- Engaged with other Key stakeholders within the local community (i.e. Local Council, Community groups or local businesses)
- Successful promotion of the event using platforms such as social media
- Point of difference for the event that sets it side from other events being held during eligibility period



# OFFICIAL OF THE YEAR

This award recognises an Official who consistently displays both outstanding personal attributes, administerial skills and education within our Motorcycling community. Officials include, Stewards, Clerk of Course, Race Secretary, Technical Officers and Coaches.

## NOMINATE HERE

#### CRITERIA:

Taken into consideration will be all Motorcycling events that the individual participated in as an official during the eligibility period.

#### 1. ELIGIBILITY

- Must be a current MA accreditation holder
- Must have officiated at a Motorcycling NT permitted event during the eligibility period

#### 2. PERSONAL VALUES

- o Consistently displays a positive attitude and passion for Motorcycling
- Outstanding interpersonal skills
- Has a service mindset
- Is fair, honest and courteous when interacting with riders, officials and other volunteers.

#### 3. PERFORMANCE

- Has a through understanding of the general competition rules abiding to the discipline/s that they officiate within
- o Is fair & courteous when interacting with riders, volunteers and other officials
- Is organised and completes all tasks required of them including all paperwork and notifications to riders, community and Motorcycling NT published, completed or submitted accurately and on time
- Runs events/programs consistently to schedule
- o Prioritises compliance, education and positive rider experience above all else
- Encourages riders and displays the attributes of an excellence role modal at all times
- Encourages other members of the community to participate as a volunteer or official
- Or provides excellent outcomes for clubs and riders through their coaching programs



# HALL OF FAME

This award recognises an individual's extraordinary performance over a career by riders and special members who have achieved at the highest level within their discipline across State, National and International levels

## NOMINATE HERE

#### CRITERIA:

#### 1. ELIGIBILITY FOR COMPETITOR MEMBERS

- Must be an Australian Citizen or Resident or have held a competition licence issued by MA and MNT for a significant period of time;
- Have commenced riding/competitive journey with a current or previously affiliated MNT Club;
- Be a superior achiever at the highest level competition in their chosen discipline;
- Have participated in a discipline which is one of national or international significance;
- Potential inductees shall not be considered until after at least a two-year waiting period following retirement from their highest level of competition in a particular discipline; or the performance of a particularly outstanding achievement that warrants special recognition or where in the relevant discipline, age is not a barrier to continued competition.

## 2. ELIGIBILITY FOR SPECIAL MEMBERS

- For consideration in this category, the potential inductee must have made a very significant contribution to motorcycling sport at the state, national or international level.
- Potential inductees may also have been competitors or have been involved in other areas of motorcycle sport, but their achievements must satisfy the criterion detailed in competitive members above.
- Irrespective of their area of involvement, potential inductees must have been committed to the development of the sport, have contributed to motorcycling sport at the highest level either nationally or internationally and risen to the highest level possible within their chosen field.
- Long service is not sufficient on its own to quality a person a potential inductee.

# IAN JORDAN SHIELD - SENIOR SPORTSMANSHIP

- Must be a current MA licence holder
- Must be a current financial member of MNT affiliated Club
- Must have ridden at a club level
- Must meet the age eligibility

#### 2. PERSONAL VALUES

- Nominee demonstrates exceptional/outstanding acts of sportsmanship during and/or out of competition
- Nominee demonstrates exceptional/outstanding acts of fair play during competition
- Nominee demonstrates exceptional/outstanding acts of co-operation, courtesy and respect to officials, volunteers and competitors
- Nominee acts with honesty, integrity and interacts with others in the spirit of friendly competition and cooperation



The sportsmanship award recognises a junior competitor who best exemplifies the spirit of MNT and MA (Ride Race Enjoy) through their attitude, demeanor, and treatment of fellow competitors, coaches, and officials. The award recipient should accept victory or defeat graciously.

#### CRITERIA:

#### 1. ELIGIBILITY

- Must be a current MA licence holder
- Must be a current financial member of MNT affiliated Club
- Must have ridden at a club level
- Must meet the age eligibility

#### 2. PERSONAL VALUES

- Nominee demonstrates exceptional/outstanding acts of sportsmanship during and/or out of competition
- Nominee demonstrates exceptional/outstanding acts of fair play during competition
- Nominee demonstrates exceptional/outstanding acts of co-operation, courtesy and respect to officials, volunteers and competitors
- Nominee acts with honesty, integrity and interacts with others in the spirit of friendly competition and cooperation



# RIDER OF THE YEAR - EACH DISCIPLINE

This award recognises a rider who consistently displays both outstanding personal attributes and performance within our Motorcycling community within their discipline.

#### CATEGORIES IN EACH DISCIPLINE INCLUDE:

- o Junior Rider Enduro, Motocross, Quad, Road Race, Speedway
- o Senior Rider Enduro, Motocross, Quad, Road Race, Speedway

# NOMINATE HERE

#### CRITERIA:

This award is based on the accomplishments of the individual in respect to his/her overall results. Taken into consideration will be all motorcycling events that the individual participated in at a competitive level.

#### 1. ELIGIBILITY

- Must be a current MA licence holder
- Must be a current financial member of MNT affiliated Club
- Must have ridden at a club level
- Must meet the age eligibility for their category
- Must have ridden at the relative MNT discipline State Championship or series where applicable
- Must have ridden at the relative MA discipline State Championship or series where applicable

## 2. PERSONAL VALUES

- o Consistently displays a positive attitude.
- Is fair and courteous when interacting with peers, officials and other volunteers.
- Encourages other riders and displays the attributes of an excellent role model at all times.

#### 3. PERFORMANCE

Has consistently and repeatedly achieved podium positions:

- o in any club level series or event
- o interclub event or series
- o open event or series

For purpose of this criteria podium refers to 1st, 2nd, 3rd, 4th or 5th placings.
