Progressing steadily Non-competitive licencing fixed to work within Competitive Events Race Secretary Access and Club Admin to be implemented by end of June OEL function to be released – Next Month

One Event Licence – Licencing Document

Can only be used in events below Open Level All Open, State and National events to only accepted Annual National Licence Holders

Slips and Trips – Club owned Premises

No covered under MAIL Insurance Clubs should investigate options for insurance MAIL could look into bulk insurance policies for all clubs

Insurance Update

Track Standards MA have employed a person to do Quality Control and they will be commencing soon.

Major Risk – non compliance with track standards – MA board has been working with MAIL re gross negligence wording within the policy – a circular is to be distributed prior to wording change occurs

Learnings from Fatality in 2014 "Confidential"

Qld work health and safety have worked with MA – lack of compliance with track standard contributed to the death – a statement of facts have been compiled and MA was found guilty re: not complying with track standards and received a fine of 100,000 - MA board had to make a decision to continue with the event even though there were some issues with the track.

Take away is that you don't need an accident to happen to find yourself in non-compliance to track standards and MOMs.

Clubs and SCB's operating outside of the MoMs and GCRs SCB permitting events outside of the licencing documents SCB permitting events with supplementary regulations outside of the GCR's and MoMs Clubs operating events outside of the GCR's or MoM's

Take away is that MAIL will NOT cover insurances
